Staff Development: MTSS. Been doing K-2 grade level data meetings. Adding EduClimber to use for next year. Meet with MTSS team in June and get a timeline for year out. Two workdays May 30 and June 6 AM met for reflecting with processes and data + planning for next year. June 30 and July 1 is MTSS Secondary summit to explore models, tools and processes. Secondary will reach out to Kendra this Spring. Quarterly 1 hour (11am) data meetings will be held with K-2.

Curriculum scope and sequence: Came up through strategic planning process. Not certain on where to prioritize. Will review plan with Ernie and set a timeline based on NDE's standards updates. Look at district policies and plans first.

Danielson: Will focus on one indicator each year. It has not been selected yet for 25-26. Procedures (2C). Kick off in August and follow up in October to allow for tweaks to what they are teaching.

CIP year 3. Still switching from Cognia and get it going. Have goals set and putting action plan in place. Looking at nailing down surveys. On summer MTSS/CIP workday, can meet to strategize for following year (purpose and a plan). They will meet during the summer.
